#### How much does the program cost?

QAS is \$295 for members of FSAE and Participating SAEs and \$395 for non-members.

### How do I get the member rate if my SAE is participaing in OAS?

Each participating SAE has a unique coupon code for their members to use to receive the \$295 member rate. If you are a member of a participating SAE, you must use this coupon to receive the discount. Contact your SAE for your coupon code.

### Is there any in-person element to QAS, or is it all online?

The program is all online. All educational material is delivered through videos of the speakers with PowerPoints of their presentations available in the portal.

#### How long do I have to complete the QAS program?

You have 12 months from the date of purchase to the complete the program.

#### What is a passing score?

You must receive an 80% on each module in order to pass the certificate program.

### Will I receive a certificate upon passing the QAS program?

Yes. At the conclusion of the program, after passing each module test with an 80% or better score, you will be able to automatically print off a passing certificate.


